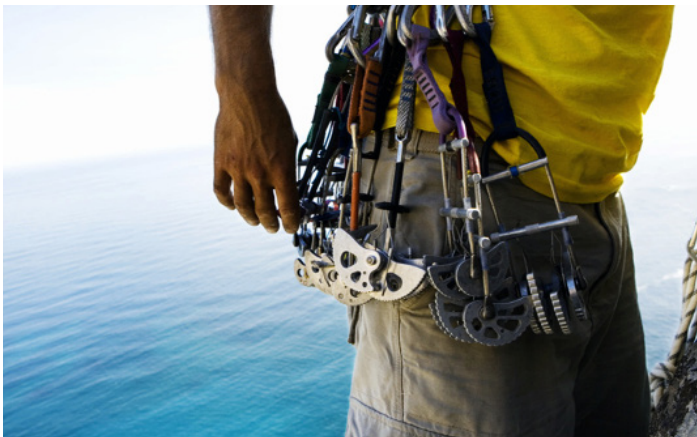

## OHSAS 18000 OCCUPATIONAL HEALTH AND SAFETY



- It enables the organization to manage operational risks reduction and the well being of employees
- Extent of application depends on nature of activities, complexity and other stake holders,
- Prioritize the same and take action to eliminate the cause
- Minimize the impact through Hazard Identification & Risk Assessment (HIRA)
- Emergency Preparedness plan

## ISO 22000 FOOD SAFETY MANAGEMENT SYSTEM

Addresses the issues concerning Food Hazards in the entire Food Chain, i.e from agriculture including usage of pesticide in the fields. The Certification covers for manufacturing, transport & storage operators, process industries and retail & food outlets including catering and packing companies.

### Key Elements include

- Interactive System Management.
- Control of food safety hazards through pre-requisite programmes and HACCP plans
- Continual improvement and upgrading the Management System.
- Organization's preparedness to deal with contamination of product which becomes unsafe for human consumption.

## ISO 13485 MEDICAL DEVICES

- Comprehensive Management System for the design and manufacture of medical devices and related services for regulatory requirements.
- Sterilization(Gas, Steam,IR radiation) and its validation play a very important and crucial role
- Electro Medical devices need EMC/ Electricity Safety Compliance
- Three categories of Medical Devices:General / Active Implantable / Invitro Diagnostic Devices
- Global Harmonized Task Force(GHTF) working with regulatory markets such as EU (CE Mark), USFDA and other developed countries.
- This standard superseded earlier standards such as as ISO 46001 and ISO 46002.

## ISO 27001 INFORMATION SECURITY MANAGEMENT SYSTEM ( ISMS )

- Focus for providing a model for establishing, implementing, operating, monitoring, reviewing, maintaining and improving an Information Security Management System. ISMS were published in Oct 2005
- ISO/IEC 17799 Implementation guide and replaces old BS7799-2 standard.

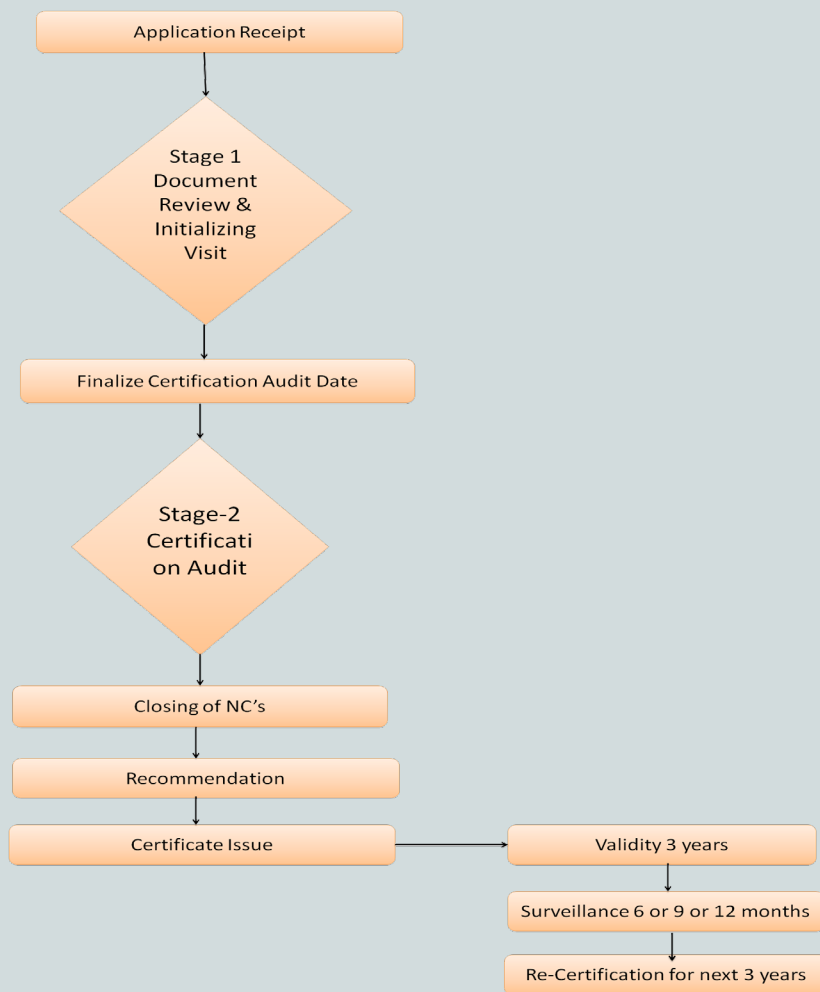

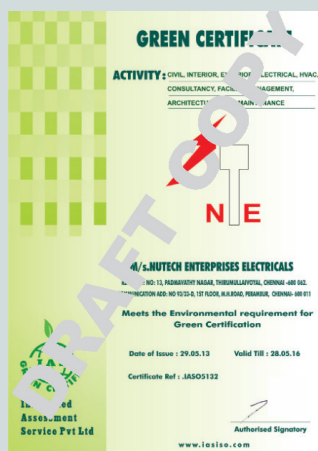

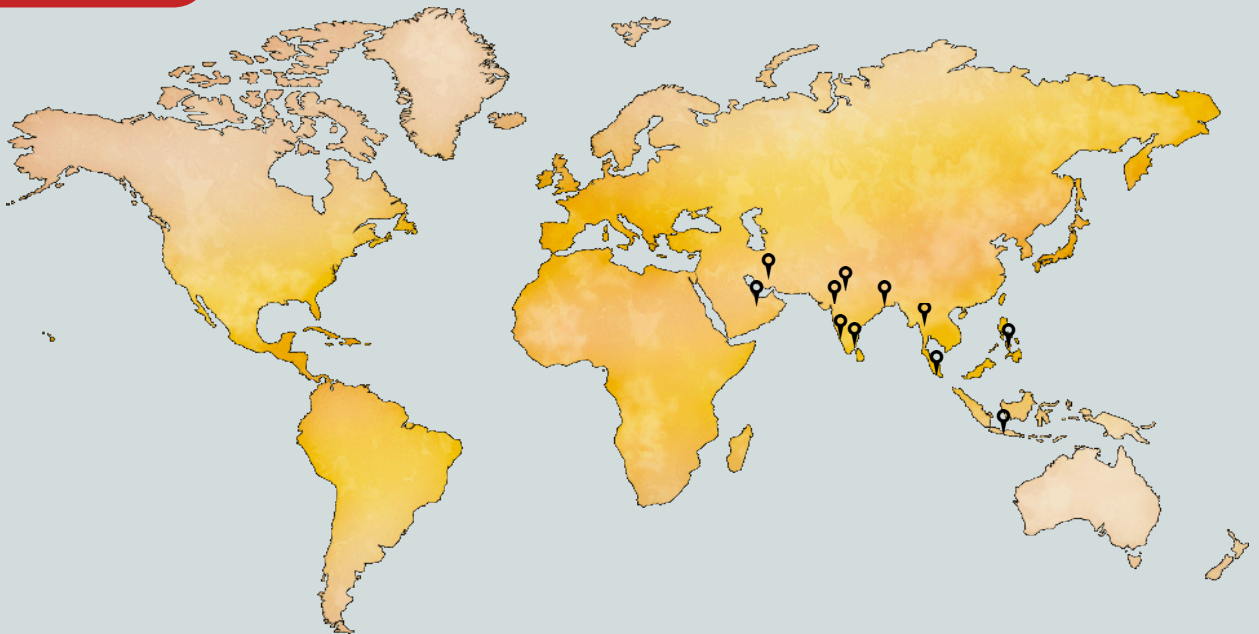
